### **Position Overview**

The Tank Farm Attendant is responsible for supervising all yard activities including the safe delivery and refuelling of petroleum products, performing necessary pre-operations checks, inspections, maintenance on equipment, ensuring inventory is adequately maintained and in compliance with all applicable Federal & Provincial Legislation including North Atlantic's Health, Safety & Environmental Management System.

This is a permanent full-time position working various shifts 7-days a week and is located in Donovan's Industrial Park.

### **Duties and Responsibilities:**

- Processing/verifying truck tickets/batches to ensure accurate and timely customer invoicing
- Opening the facility including the operational start-up of all pumps, initiate electrical supply and perform pre-operations checks
- Monitor/gage tanks to record inventory of product. Cross reference inventory check with previous shift to ensure accuracy. Conduct a weekly dip of the oil water separator and maintain record.
- Maintain fuel inventory levels for both diesel fuel and propane. This would include ordering and receiving fuel.
- Supervise the loading process and address any health and safety issues, as well as any operational issues on site immediately.
- Complete transportation and dangerous goods documents for both company distributors and customers loading product at the facility. For bulk haulers bringing in product to the facility, ensure transportation of dangerous goods documents are received and accurately reflect the quality and type of goods ordered.
- Maintain all load slips and perform daily reconciliation report. Submit daily to Invoice Processing Department.
- Update truck cards on the card reader system for company distributors. Reconcile at end of day delivery load slips and submit summary to invoice processing by courier.
- Conduct yard orientation for new drivers loading at the facility.
- Regular inspection of equipment to determine if any preventative maintenance is necessary. Obtain approval and arrange for maintenance on equipment as needed.



- Calculate volumes of propane lifted using external temperature readings on the propane tanks.
- Provide direction and guidenace to distrituors & bulk haulers with on the loading and off loading processes
- Receive propane cylinders and evacuate propane using evacuation station. Vent the vapour and use gas detector to ensure zero LEL (lower exposure limit) before shipping cylinders out for refurbishment and/or requalification. Records of external visual inspection on a database as well as records on all cylinder movement.
- Respond to any emergency response situation involving liquid petroleum or propane. Ensure adherence to established reporting requirements as described in North Atlantic's emergency plans.
- Escalate any major operational issues such as equipment failure immediately to the Operations Manager.
- Ensure adherence to North Atlantic's Health, Safety, & Environmental Management System including policies, procedures, both Federal & Provincial Regulatory Legislation, standards and codes.
- Be able to demonstrate a strong commitment to health and safety in the workplace.
- Other duties as required.

- Trained and experienced with Canada's Transportation of Dangerous Goods Act and Regulations
- Working knowledge of Environmental Legislation
- Fork Lift Operator Certification
- Strong verbal and written communication skills
- Strong organizational skills and planning abilities
- Ability to lift up to 50 lbs
- Confined Space Training (considered and asset)
- Fall Protection Training (considered and asset)
- Canadian Fuels Association Driver Certification (considered and asset)
