Position Overview

Reporting to the Chief Financial Officer (CFO), and taking direction from the North Sun executive team, the Director of Finance is a strategic visionary guiding the organization toward financial excellence. The position is responsible for the optimization of finance services, applications and processes and driving innovative solutions that align with the organization's objectives.

The role will work closely with internal stakeholders to formulate plans that drive process improvement, implement departmental budgeting and reporting, develop and track Key Performance Indicators and ensure consistent application of processes and controls. Working closely with the executive team, Controllers and other leaders, you will play a pivotal role in designing and implementing the digital transformation of the finance function.

The Director of Finance will lead the Accounts Payable, Accounts Receivable, Credit, and Financial Analysis functions for North Sun Energy. The role will oversee cash management, tax remittances, risk and insurance, capital reporting, finance systems, intercompany and consolidation functions and support the needs analysis of new business opportunities.

Roles and Responsibilities:

- Develop and implement consistent financial strategies, policies, and procedures across all entities.
- Support the development of automated reporting for multiple retail and QSR locations.
- Lead the annual budgeting process and monthly/quarterly financial forecasting efforts.
- Oversee consolidated budgeting, forecasting, financial reporting, and cash flow management.
- Develop and oversee delivery of internal reports and KPIs to help key personnel manage operations.
- Work with Controller and staff to ensure the effective and timely delivery of all accounting and finance operations reports and implementation of control frameworks.
- Provide leadership and direction to the finance team, including Accounts Payable, Accounts Receivable, business analysis, tax, treasury and risk management.
- Foster a culture of performance with emphasis on accountability, collaboration, and continuous improvement.
